WITNESSETH

WHEREAS, the COUNTY has funds available to certain qualified real property owners for the purpose of providing grants for the assistance of said owners in the repair and rehabilitation of certain improvements (existing housing) found upon such owned real property, said real property being located within Polk County, Florida; 1551 Tangelo Street, Lake Wales, FL 33898.

- 2. The OWNER(s) will indemnify and hold the COUNTY harmless together with all the COUNTY'S employees and designated representatives, from any and all liability, claims, action suits or demands for injuries, death or property damage arising out or in connection with the repair and rehabilitation of the OWNER(s) property due to the OWNER(s) negligence.
- 3. The OWNER(s) filed application with the COUNTY dated <u>December 29, 2023</u>, for Rehabilitation/Reconstruction Assistance, and it is incorporated as part of this Agreement, by this reference.
- 4. This Agreement shall be binding upon the OWNER(s), and the estate, personal representatives, heirs and devises of a deceased (OWNER(s).
