Whereas, the County has funds available for certain qualified real property owners for the purposes of providing grants for the assistance of said owners in the repair and rehabilitation of certain improvements (existing housing) found upon such owned real property; said real property being located within Polk County, Florida 1810 East Georgia St., Bartow, Fl. 33830.

Legal Description: The West ½ of Lots 1, 2, 3, 4, 5 and 6, Block B, HIGHLAND PARK, according to the plat thereof recorded in Plat Book 9, Page 4 of the public records of Polk County, Florida.

Whereas the County has determined that the Owner(s) meets all the eligibility criteria established for the aforementioned grants and is therefore eligible for a grant pursuant to the terms and provisions of said program.

Now, Therefore, in consideration of the covenants contained herein, the parties mutually agree as follows:

- 1. The Owner(s) agrees to accept Nine Thousand Nine Hundred Fifty-Two and 00/100 Dollars (\$9,952.00) as a grant to be used for construction soft costs and temporary location benefits.
- 2. The Owner(s) will indemnify and hold the County harmless together with all the County's employees and designated representatives, from any and all liability, claims, action suits or demands for injuries, death or property damage arising out or in connection with the repair and rehabilitation of the Owner(s) property due to the Owner(s) negligence.

- 3. The Owner(s) filed application with the County dated <u>6/25/2024</u> for Replacement/New Construction Assistance, and it is incorporated as part of this Agreement, by this reference.
- 4. This Agreement shall be binding upon the Owner(s), and the estate, personal representatives, heirs and devises of a deceased (Owner(s).
- 5. The use in this Agreement of the word Owner shall apply to the plural as well as the singular.
