

**SIXTH AMENDMENT TO THE MASTER PURCHASE AGREEMENT FOR POLK
COUNTY RADIO COMMUNICATIONS EQUIPMENT AND SERVICES**

THIS SIXTH CONTRACT AMENDMENT (Sixth Amendment) is made and entered into, to be effective on October 1, 2026 (the “Effective Date”), by and between Polk County, Florida, a political subdivision of the State of Florida (hereinafter referred to as “County”) and Motorola Solutions, Inc. (hereinafter referred to as “Motorola”), a Delaware corporation authorized to conduct business in the State of Florida, with offices at 500 W. Monroe Street, Suite 4400, Chicago, IL 60661.

WHEREAS, on February 3, 2015, the County and Motorola entered into Master Purchase Agreement Motorola No. 14-90376 and County Contract No. 15-009, as subsequently amended (collectively the “Agreement”), for the purchase and installation of radio communication equipment and services;

WHEREAS, on December 13, 2016, the Agreement was amended to incorporate system upgrade services for a period of ten (10) years that will expire on September 30, 2026;

WHEREAS, the County and Motorola wish to renew the system upgrade services for an additional six (6) year period;

WHEREAS, Section 17.8 of the Agreement provides that any changes to the Agreement must be documented in writing and signed by each party’s authorized signatories.

NOW THEREFORE, in consideration of the promises and the mutual covenants contained in the Agreement, the sufficiency and receipt of which is hereby acknowledged together, the County and Motorola agree as follows:

1. The recitals stated above are true and correct and are incorporated herein.
2. The County and Motorola mutually agree to incorporate the terms and pricing of the System Upgrade Agreement Renewal, with an effective date of October 1, 2026, and continued through September 30, 2032, as set forth in Exhibit A.
3. Except as specifically revised herein or by prior amendment fully executed, the Agreement remains unamended and in full force and effect.
