WHEREAS, the Polk County Roads & Drainage Division, conducted parking studies on the following County-maintained Rural Major Collector road:

County Road 655 (Lake Shipp Drive South) (Road Number 960523) from US Highway 17 to State Road 655 (Recker Highway), Located in S-29, T-26S, R-05E, and

WHEREAS, said studies were made in accordance with the procedures established by the State of Florida Department of Transportation, and said studies verified that the parking of vehicles in this location creates a visibility concern, and

WHEREAS, under the laws of the State of Florida, the Board of County Commissioners is vested with the authority to restrict parking on County maintained roads.


