Description of Work: [Stericycle owns and operates an autoclave facility located at 4245 Maine Avenue in Lakeland, Florida on two parcels: #24-28-35-270500-000017 and #24-28-35-270501-000050. The facility has approval under the Polk County Land Development Code to operate as a "legal nonconforming facility" \(lawfully constructed at the time it was built, but would not meet current regulations\). Stericycle proposes to demolish and reconstruct a larger building on the south abutting parcel to enhance operational efficiency, increase parking and improve the site's aesthetics. There will be no substantial increase in the processing rate or number of employees at the site.](#)
