

## LAND PURCHASE AGREEMENT

## STATE OF FLORIDA COUNTY OF POLK

## WITNESSETH

WHEREAS, Owner agrees to sell to County and County agrees to purchase from Owner the lands identified as Parcel ID Numbers, as shown and more particularly described in Exhibit "A", together with all improvements, easements, and appurtenances (collectively, the "Property"), in accordance with the provisions of this Agreement.

**NOW**, **THEREFORE**, in consideration of the premises and the sum of one dollar each to the other paid, it is agreed as follows:

- (a) Owner agrees to sell and convey the Property by Special Warranty Deed, free of liens and encumbrances, unto the County, for the sum of \$221,250.00 (Two Hundred Twenty One Thousand Two Hundred Fifty and 00/100 U.S. Dollars).
- (b) The County payment of \$221,250.00 U.S. Dollars for the purchase of the Property together with applicable closing costs shall be made to the Title Agency described in Section (d) herein for disbursement at closing.
- Owner and County agree that the Special Warranty Deed shall contain a reservation that the Owner reserves unto itself, its successors and assigns an easement for ingress, egress, utility and drainage over and across the Easterly 30-feet of Parcel ID Number 293003-000000-012160 which is more particularly described in the attached Exhibit "A".
- Owner shall be responsible for the payment of any and all, current and/or past due real property taxes, or pro-rations thereof, pro-rated to the date of closing, and assessments due on the date of closing, and any payment due will be deducted at closing from the Owner's proceeds. Owner shall also be responsible for the payment of any Mortgages, Judgments and/or Liens, if any, which attach to the Property and any payment(s) due will be deducted at closing from the Owner's proceeds.

- (e) Transaction will be closed by American Government Services Corporation (the "Title Agency") and the County agrees to pay the closing fee, title search fee, owner's title insurance premium, documentary stamps and the recording of the deed.
- (f) Owner shall be responsible for the payment of all real estate fees and/or commissions or attorney's fees on behalf of the Owner, if any, and any payments due will be deducted at closing from the Owner's proceeds. County represents that it has not incurred the services of a broker.
- (g) Any personal property located on the Property not removed after 14 days of transaction closing shall be considered abandoned by the Owner.
- (h) The Owner agrees and expressly acknowledges that the monies paid, and other consideration given in accordance with this Agreement is just and full compensation for all property interest and or claims arising from this acquisition and no other monies including fees and/or cost are owed by the County to Owner.
- \* THIS AGREEMENT IS SUBJECT TO FINAL APPROVAL BY THE BOARD OF COUNTY COMMISSIONERS OF POLK COUNTY, FLORIDA.
