

MASTER CONSULTANT AGREEMENT
#2022-088
AMENDMENT #2

This Amendment #2, effective as of the date executed by the County, is hereby entered into by Polk County, a political subdivision of the State of Florida (the "County") situated at 330 West Church Street, Bartow, Florida, 33830, hereinafter referred to as the County, and HNTB Corporation (the "Consultant"), an Delaware corporation, located at 555 North Broadway Avenue, Bartow, Florida 33830.

WITNESSETH:

WHEREAS, the County and the Consultant entered into a Master Consultant Agreement dated October 4, 2022 (the "Agreement") for the purpose of providing professional services in connection with the performance of certain professional consultants for a wide range of technical, engineering, scientific, and architectural services for the planning, design, construction, operation, monitoring and maintenance of the roadway network, which is more fully set out in the Scope of Services; and

WHEREAS, pursuant to Section 3.1.2 of the Agreement, the Consultant may request the County approve the Consultant's proposed adjustment to the amounts stated on the Fee Schedule; and

WHEREAS, the Consultant requested and the County has agreed to an adjusted Fee Schedule attached as Exhibit "B-3", which shall operate prospectively only and shall not alter fee schedules for Consultant Services Authorizations in effect at the time of the amendment; and

WHEREAS, pursuant to Section 22.0 of the Agreement, the County and the Consultant mutually agree to amend the Agreement as set forth below.

NOW, THEREFORE, the County and the Consultant, hereby agree to the following:

1. Exhibit "B-2", Fee Schedule of the Agreement is hereby revised and replaced in its entirety with the adjusted Fee Schedule attached hereto as Exhibit "B-3".
2. The Agreement, as amended by this Amendment #2, continues in full force and effect.
