

Commence at the southwest corner of said Northwest 1/4 of the Southwest 1/4 for the POINT OF BEGINNING; thence North 00°33'20" West, along the west line of said Northwest 1/4 of the Southwest 1/4, a distance of 1319.65 feet to the northwest corner of said Northwest 1/4 of the Southwest 1/4; thence North 89°22'23" East, along the north line of said Northwest 1/4 of the Southwest 1/4, a distance of 1326.80 feet to the northeast corner of said Northwest 1/4 of the Southwest 1/4; thence South 00°33'32" East, along the east line of said Northwest 1/4 of the Southwest 1/4, a distance of 40.00 feet; thence South 89°22'23" West, along a line 40.00 feet south of and parallel with aforesaid north line of the Northwest 1/4 of the Southwest 1/4, a distance of 1236.86 feet to the point of curvature or a curve to the left having a radius of 50.00 feet, a central angle of 89°55'43", a chord bearing of South 44°24'31" West, and a chord distance of 70.67 feet; thence Southwesterly along the arc of said curve 78.48 feet to a point on a line being 40.00 feet east of aforesaid west line of the Northwest 1/4 of the Southwest 1/4; thence South 00'33'20" East, along said line 40.00 feet east of and parallel with said west line, 1229.77 feet to the south line of said Northwest 1/4 of the Southwest 1/4; thence South 89°27'21" West, along said south line, 40.00 feet to the POINT OF BEGINNING.
