

Community Petition in Support of Allowing a Neighbor to Park Company Vehicles in Her Driveway

We, the undersigned residents of **FLOY DRIVE**, respectfully petition Polk County Code Enforcement to **allow our neighbors, Cesar and Christi Ulloa located at 5760 Floy Drive, to continue parking their company vehicles in their private residential driveway.**

Our neighbor is a valued member of our community who uses her company vehicle responsibly, parking it in her own driveway for limited periods (approximately 30 minutes to an hour daily). The vehicle is not obstructing traffic, creating noise, or causing any disruption to the neighborhood. It is well-maintained and parked in a safe, orderly manner.

We believe that **residents should have the right to park their legally registered vehicles, including company-branded vehicles, in their own driveways**, provided they do not violate any safety or nuisance laws. Enforcing restrictions in this case would be an unnecessary burden and would not serve the public interest.

We ask Polk County Code Enforcement to exercise discretion and **permit this reasonable use of private residential property.**
