Coastal Waste & Recycling does not have any criminal cases or pending and threatened criminal cases involving a felony conviction or a plea of nolo contendere to a felony charges. (i)(ii)

Coastal Waste does not have any cases that resulted in a conviction or adjudication and all pending cases based on a violation of a local, state, or federal environmental law. (iii)

Coastal does not have any pending cases based on a violation of a local government ordinance or any contract including, but not limited, to a franchise agreement concerning the collection of solid waste. (iv)

However, Coastal Waste & Recycling has been assessed liquidated damages/ administrative fines: (v)

Administrative Fines/Liquidated Damages

Miami Dade County - 2019 through 2020, Coastal was assessed an administrative charge of \$31,500 for missed pick-ups in Miami Dade County. This contract represents 223,000 homes that are serviced every other week. Service was recovered outside the contractual time allowed to be recovered of 24 hours but within 48-72 hours.

The City of Fort Lauderdale - The City assessed Coastal \$27,370 since the inception of the contract in 2020. The contract represents 40,218 homes, serviced every week. Administrative fines include Deliver, Exchange, Repair or Remove within 10 days (\$12,700 since 2020), Complaints that exceeded the threshold (\$6,990 since 2020), Three or more complaints from the same address (\$5,125 since 2020), Service was recovered outside the contractual time allowed to be recovered of 24 hours but within 48-72 hours.

City of Hialeah - During 2020, Coastal was assessed minor fines for the City of Hialeah. The contract represents 36,623 homes that are serviced every week. Fines were as follows: Leaving container where it blocks the driveway (7); Failure to return the container to original place (1); Failure to respond to complaint; **(1) Failure to complete a route (1) IMPORTANT NOTE: This was the only incomplete route for the company during the pandemic. The route was completed the next day.** In April 2021, Coastal was assessed \$15,800 in administrative fines for missed pick-ups. The fine was due to service recovery falling outside the contractual time allowed.

City of Augusta - Coastal began servicing the City on October 1, 2021, after acquiring Orion Waste Solutions. Fines to Orion continued during the transition. Oct 2022 – Dec 2022 - \$75,925. Jan 2023 – Dec 2023 – Including sub-contractor fines \$83,350. Jan 2024- July 2024 – including sub-contractor fines \$107,925. Please note the foregoing includes cart repairs and replacement costs.



Dear Polk County Franchise Waste Hauler:

Pursuant to Polk County Ordinance 13-069, each Non-Exclusive Commercial Franchise is required to be renewed annually. The renewal process includes an annual renewal fee in the amount of \$500 and the following:

- 1) Updated applicant information, including the identity of the applicant's principals, partners, and management. Any partnership, corporation, or other business entity must be authorized to do business within the state of Florida and must be in good standing with the Florida Department of State, Division of Corporations. (*Ordinance Section 4-1C - 1, 2a, b, & c*)
- 2) A complete list of vehicles, equipment, and other physical assets that will be used to collect and transport solid waste within Polk County, including make, model, capacity, size, type, and vehicle identification number. (*Ordinance Section 4-1C - 2d*)
- 3) A complete list of customers, the frequency of services, the identification number, size, capacity, and type of container used to collect solid waste within Polk County. (*Ordinance Section 4-1C - 2e*)
- 4) Current, original Certificates of Insurance, listing Polk County as the "Certificate Holder." Applicants are required to provide proof of comprehensive general liability and workers compensation. (*Ordinance Section 4-1C - 2g*)
- 5) Notarized Affidavit and Indemnity (*Attached*)

Each vehicle in your fleet is also required to pass an annual vehicle safety inspection. The fee for the annual vehicle safety inspections is \$200 per vehicle and will be conducted on an ongoing basis as the trucks come to the landfill or at your facility. You may also contact our office to schedule an inspection if necessary.

Polk County reserves the right to revoke and/or modify any Non-Exclusive Commercial Franchise for the collection of solid waste.
