SUBJECT: Septic Remediation Plan

Introduction and Background

Florida House Bill 1379 was signed into law in 2023 and requires comprehensive plans to further assess wastewater treatment, onsite sewage treatment and disposal systems (“OSTDS” or “septic tanks”), and sanitary sewer systems. Section 163.3177(6) Florida Statutes requires an evaluation of the feasibility of connecting properties with septic tanks to a sanitary sewer when certain density conditions are, or could be, present. Specifically, the rule requires the County to assess developments of more than fifty (50) built or unbuilt units with more than one (1) OSTDS per one acre.

To comply with the 2023 requirements, the County submitted a draft OSTDS remediation plan to the Florida Department of Environmental Protection (FDEP) and has worked closely with the State to narrow the scope of the additional information requested. In response to the State’s requests, this memorandum provides information related to OSTDS and the investments needed to connect these sites to a wastewater treatment facility.

GIS Analysis

Dewberry performed a GIS analysis to identify all developments, of more than fifty (50) built or unbuilt units with a density of more than one (1) OSTDS per acre, within unincorporated Polk County. This included subdivisions within other municipal utility service area boundaries, but outside of their respective city limits.

Dewberry acquired the most recent parcel and subdivision data from the Polk County property appraiser, septic data from the FDEP, and utility infrastructure data from the County and various municipalities for the analysis. This information was used to identify all parcels 1-acre or less with septic system and ultimately developments (or subdivisions) of more than 50 units. In the subdivision data, many subdivisions were separated by phase or tracts, and were merged to create a main subdivision. In total, 310 subdivisions were identified totaling over 36,000 OSTDSs within unincorporated Polk County.

Each subdivision was attributed with the associated wastewater treatment facility (WWTF) that would most likely receive the converted septic flows, based on the utility service area boundaries, or proximity to the service area boundary in some cases. The identified subdivision polygons were converted to centroids to perform a shortest route analysis; the centroid was utilized as the lift station location for each subdivision. The Network Trace Tool (utilizing shortest path) in ArcGIS Pro was used to generate routes along roads, from the subdivision centroid to the associated WWTF. For Polk County Utility service areas, Dewberry utilized institutional knowledge of the wastewater collection system and routed some converted septic flows to major lift stations, where appropriate. These routes were utilized as the force mains connecting the lift station to the WWTF.

The service area boundaries, city boundaries, WWTFs, subdivisions with more 50 OSTDSs less than 1-acre, and the connecting force mains are shown in **Attachment A**.

Cost Estimates

Cost estimates were developed, for each subdivision, based on the resulting information from the GIS analysis. Force main diameters were sized to maintain a velocity between 2 to 4 feet per second (fps). One lift station per identified subdivision was assumed, plus additional lift station(s) if the connecting force main length was greater than three miles. For example, if the force main connecting the subdivision centroid to the WWTF was less than 3 miles, only one lift station would be needed; if the connecting force main was 3.5 miles, it was assumed two lift stations would be needed, one at the subdivision centroid and one as a re-pump station. The following assumptions were utilized for the cost estimates.

Table 2 presents the septic to sewer conversions cost, summarized by the associated WWTF. These costs do not include any upgrades that may be required at each facility. A detailed table with each identified subdivision is provided in **Attachment A**.

WWTF Capacity Analysis

Polk County made several attempts to acquire local municipal input. Specifically, the County requested: current wastewater collection system GIS infrastructure data, projected wastewater flows for both the 10- and 20-year planning periods, plant capacity(s) for both the 10- and 20-year planning periods. Due to the limited response, for many of the municipalities wastewater flow projections were estimated based on Discharge Monitoring Reports (DMRs) submitted to the FDEP and the Southwest Florida Water Management District's (SWFWMD) parcel-level population projection model.

The SWFWMD parcel-level projection model projects future population growth at the parcel level and is limited to BEBR's latest county-level forecasts. The projection model allows you to develop population projections at the service area boundary level, limited to BEBR medium growth rates. The model results provide population growth rates in 5-year increments, with a base year of 2022, for 2025, 2030, 2035, 2040, 2045, and 2050. This growth model is used for permitting of potable water system quantities, and therefore is a reasonable assumption for wastewater flow projections.

Dewberry acquired 6-months of DMR data from the FDEP Oculus database and calculated the 6-month average effluent flow. This average flow was used as the current WWTF flow. The population projection model compound growth rates were then applied to the 6-month average flow to calculate the projected 2034 and 2044 wastewater flows. The current FDEP Domestic Wastewater Facility permits were the source for the 2034 and 2044 permitted capacity. Based on the limited input, it is unknown if any facility upgrades are planned beyond what was stated in the permits.

Table 3 summarizes the projected wastewater flows, estimated facility capacities, and compares facility capacity versus projected flow prior to any septic to sewer conversions and after build-out of the septic to sewer conversions. Based on this comparison, it appears some WWTFs will need future increased capacity. A cost for plant upgrades was estimated utilizing \$40 per gallon. Note that these flow projections do not include any planned septic to sewer conversions anticipated by the local municipality.

Summary and Conclusion

A total of 310 subdivisions of more than fifty (50) built or unbuilt units with a density of more than one (1) onsite sewage treatment and disposal system per acre, within unincorporated Polk County were identified totaling 36,087 OSTDSs. Of this total, only 30% of the total OSTDSs are within Polk County Utilities service areas. The combined average annual daily flow is 9.74 million gallons per day (mgd) with a total estimated cost to connect of \$1.42 billion, with an additional \$295.8 million in potential WWTF improvements as presented in **Table 4**. These numbers do not include any septic to sewer conversions within the municipal city limits.

Polk County concurs that septic systems that are not properly maintained can be a significant source of nutrients in impaired waters based on their proximity to surface waters, soil characteristics, age of systems and other factors. The County is identifying and evaluating opportunities to convert septic tanks to centralized wastewater treatment. To be able to plan for such future connections, the County would require substantial State or Federal funding. Until the funding is secured, the potential number of connections over the 20-year period cannot be quantified.

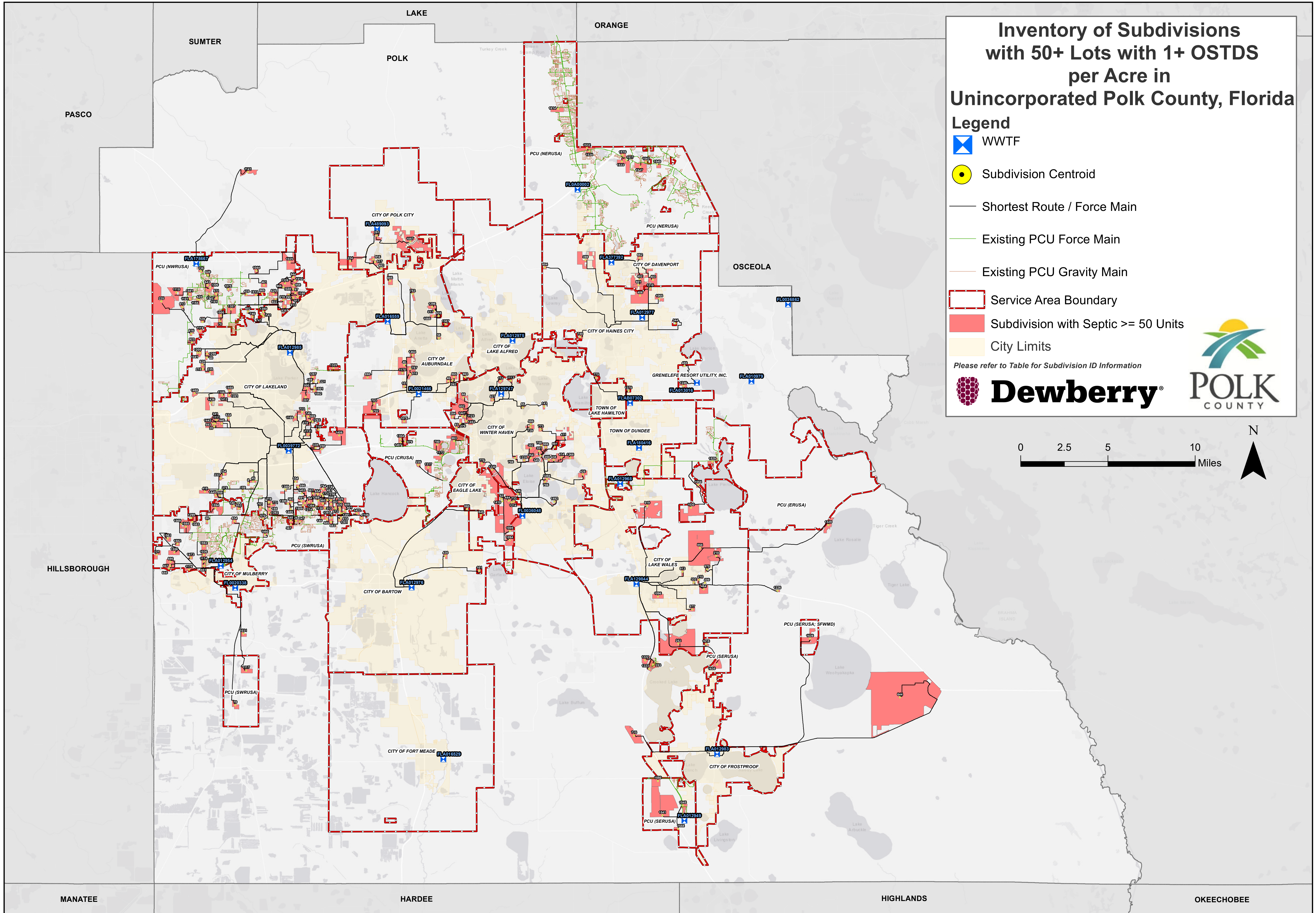
