

RESOLUTION NO.: _____

WHEREAS Section 316.008, Florida Statutes, allows local governments to prohibit or regulate the use of certain roadways by any class or kind of traffic found to be incompatible with the normal and safe movement of traffic, and

WHEREAS the following roads are County-maintained Rural Major and Minor Collector roads:

County Road 655 (Alturas Road North) (Road Number 060901) from Central Avenue to State Road 60, Located in S-9, T-30S, R-26E, and

Alturas Loop Road (Road Number 061611) from Central Avenue to County Road 655 (Alturas Road North), Located in S-16, T-30S, R-26E, and

Poinsettia Avenue (Road Number 061602) from Perch Lake Road to Alturas Road, Located in S-16, T-30S, R-26E, and

WHEREAS the following roads are County-maintained Local Residential roads:

Alturas Road (Road Number 062103) from Alturas-Babson Park Cutoff to Poinsettia Avenue, Located in S-16, T-30S, R-26E, and

Central Avenue (Road Number 061606) from County Road 655 (Alturas Road North) to Alturas Loop Road, Located in S-16, T-30S, R-26E, and

Third Street (Road Number 061605) from Poinsettia Avenue to Oak Drive, Located in S-16, T-30S, R-26E, and

WHEREAS the conveyance of commercial truck traffic along these roads has been found to be incompatible with the normal and safe movement of traffic,

NOW, THEREFORE, BE IT RESOLVED that the Polk County Roads & Drainage Division is herewith directed to cause County Road 655 (Alturas Road North) to be posted "No Thru Trucks" from Central Avenue to State Road 60, and Alturas Loop Road to be posted "No Thru Trucks" from Central Avenue to County Road 655 (Alturas Road North), and Poinsettia Avenue to be posted "No Thru Trucks" from Third Street to Alturas Road, and Alturas Road to be posted "No Thru Trucks" from Alturas-Babson Park Cutoff to Poinsettia Avenue, and Central Avenue to be posted "No Thru Trucks" from County Road 655 (Alturas Road North) to Alturas Loop Road, and Third Street to be posted "No Thru Trucks" from Alturas-Babson Park Cutoff to Poinsettia Avenue, and Central Avenue to be posted "No Thru Trucks" from Poinsettia Avenue to Central Avenue.


