MASTER CONSULTANT AGREEMENT #2022-098 AMENDMENT #1

- 1. Exhibit "B", Fee Schedule of the Agreement is hereby revised and replaced in its entirety with the adjusted Fee Schedule attached hereto as Exhibit "B-2".
- 2. The Agreement, as amended by this Amendment #1, continues in full force and effect.
