LAND PURCHASE AGREEMENT

COUNTY OF POLK STATE OF FLORIDA

THIS AGREEMENT made and entered into this _____ day of June, 2024, between TERRIE DULAC, whose address is 2137 Stonehenge Circle, Akron, Ohio 44319-5507, hereinafter referred to as "Owner", and POLK COUNTY, a political subdivision of the State of Florida, whose mailing address is Post Office Box 9005, Bartow, Florida 33831-9005, hereinafter referred to as "Purchaser".

WITNESSETH

WHEREAS, Owner agrees to sell to Purchaser and Purchaser agrees to purchase from Owner the land identified as Parcel ID Number 313211-000000-012070, located in Polk County, Florida, as further described in Exhibit "A", together with all improvements, easements, and appurtenances, (collectively, the "Property"), in accordance with the provisions of this Agreement.

NOW, THEREFORE, in consideration of the premises and the sum of One Dollar each to the other paid, it is agreed as follows:

- (a) Owner agrees to sell and convey the Property by Warranty Deed, free of liens and encumbrances, unto Purchaser, for the sum of \$5,200.00 (Five Thousand, Two Hundred Dollars).
- (b) Purchaser shall pay unto the Owner the total sum of \$5,200.00, by County Warrant, within ninety (90) days from the date hereof upon simultaneous delivery of such instrument of conveyance.
- (c) Owner shall be responsible for the payment of any past due property taxes, or current year taxes for which no tax bill is available yet (if any) pro-rated through the date of closing. Purchaser shall be responsible for the recording of the deed of conveyance.
- (d) Owner shall be responsible for the payment of all real estate fees or commissions due, if any, and any payment(s) due will be paid by the Owner to the appropriate broker. Purchaser represents it has not incurred the services of a broker.
- (e) The Owner agrees and expressly acknowledges that the monies paid, and other consideration given in accordance with this Agreement is just and full compensation for all property interest and/or claims arising from this acquisition and no other monies including fees and/or costs are owed by the County to the Owner.
