






RIGHT-OF-WAY AGREEMENT

STATE OF FLORIDA COUNTY OF POLK

THIS AGREEMENT made and entered into this <u>/8</u>^{*} day of June, 2025, by and between **CITY OF LAKE ALFRED**, a Florida municipal corporation, whose mailing address is 120 E. Pomelo Street, Florida 33850 ("Owner"), and **POLK COUNTY**, a political subdivision of the State of Florida, whose mailing address is P.O. Box 9005, Drawer RE-01, Bartow, Florida 33831-9005 ("County").

WITNESSETH

WHEREAS, the County requires the lands described as Parcel Numbers 100, 145 and 146 as more particularly described in Attachments "A", "B" and "C", respectively, (the "Property), as additional right-of-way, for the construction and maintenance of an authorized road known as County Road 557 ("Project") and the Owner is required to furnish same for such purpose; and

NOW, **THEREFORE**, in consideration of the premises and the sum of One Dollar each to the other paid, it is agreed as follows:

- (a) The Owner agrees to donate and convey a fee interest in Parcels 100 and 145, by City Deed, free of liens, unto the County.
- (b) The Owner agrees to sell and convey unto the County a fee interest in Parcel 146, by City Deed, free of liens, together with any improvements for the amount of \$550,000.
- (c) The County agrees to pay for all closing costs associated with the transaction including the recording of the deeds and documentary stamp taxes, if applicable, and any ancillary recordable documents.
- (d) The County agrees to grant an easement, when requested, to the Owner allowing for the future construction and operation of a recreational dock across Parcel 146 to the lake. The Owner agrees said dock will be constructed in a manner as to not impact the permitted volume of the Flood Plain Compensation Site. Construction and operation of said dock will be at the Owner's expense.

- (e) The County agrees to relocate, or reimburse the Owner for reasonable costs associated with the relocation of, any portion of a 12-inch water line located within Parcel 145, if any.
- (f) The County acknowledges and agrees that it will relocate the existing monument sign for the Lake Alfred Pines development in conjunction with the Project. In the event that it is not feasible to relocate the sign the County will reconstruct a similar sign as a replacement. Said sign and associated landscaping will be maintained in accordance with that certain Developer's Agreement dated June 5, 2023 and recorded in O.R. Book 12720, at Pages 140 through 178, Public Records of Polk County, Florida.
- (g) The County acknowledges that this conveyance of the Property for right-of-way is in lieu, and under threat of condemnation.
- (h) The Owner agrees and expressly acknowledges that the conveyance of the Property and any considerations given in accordance with this Agreement are just and full compensation for all property interest, and/or claims arising from this acquisition and no other monies including fees and/or costs are owed by the County to Owner.
