RESOLUTION APPROVING THE EXCHANGE OF PROPERTY BETWEEN POLK COUNTY AND TAMPA ELECTRIC COMPANY

WHEREAS, pursuant to Florida Statutes §125.37, the Board of County Commissioners (BOCC) is authorized to exchange County property, not needed for County purposes, for other property when it is in the best interest of the County to do so; and

WHEREAS, Tampa Electric Company, a Florida corporation ("TECO") is the fee owner of a parcel of land, identified as Parcel ID Number 262916-689000-014801 which parcel is more fully described in Exhibit "A" attached hereto and made a part thereof ("TECO Parcel"). The TECO Parcel is located along Eagle Lake Loop Road in the Winter Haven area immediately adjacent to property owned by the County; and

WHEREAS, the County is the fee owner of a parcel of land, identified as Parcel ID Number 233201-000000-032020 which parcel is more fully described in Exhibit "B" attached hereto and made a part hereof ("County Parcel"). The County Parcel is located along Fort Green Road in the Bradley area and is no longer needed by the County. The County Parcel is located immediately adjacent to, and surrounded by, property associated with the TECO Polk Power Station; and

WHEREAS, to acquire the TECO Parcel it is proposed that the County Parcel, which is not needed for County purposes, be exchanged for the TECO Parcel owned by TECO; and

WHEREAS, it is in the best interest of Polk County to exchange property not needed for County purposes for the property owned by TECO; and

WHEREAS a notice of the intent of the BOCC to consider adoption of a resolution approving the exchange of property was duly published in the Lakeland Ledger, as required by Florida Statute §125.37 on November 22, 2023 and on November 29, 2023.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF POLK COUNTY, FLORIDA, IN REGULAR MEETING ASSEMBLED THIS 5TH DAY OF DECEMBER, 2023:

- 1. The exchange of property between Polk County and Tampa Electric Company, is approved.
- 2. Tampa Electric Company shall convey to Polk County, a Political Subdivision of the State of Florida the TECO Parcel.
- 3. In exchange for the conveyance of the TECO Parcel, the Chairman of the BOCC is authorized, on behalf of the Board, to execute a County Deed transferring the County Parcel to TECO.
