COUNTY DEED

THIS DEED, made this 7th day of November, 2024, by **POLK COUNTY**, a political subdivision of the State of Florida, Grantor, to **JAMES MANGAN**, whose address is, 3063 Butler Bay Drive N., Windermere, Florida 34786, Grantee.

WITNESSETH: That the Grantor, for and in consideration of the sum of \$1.00, to it in hand paid by the Grantee, receipt whereof is hereby acknowledged, has Granted, bargained, and sold to Grantee, his heirs and assigns forever, all the right, title, interest, including interests, if any, in rights which may have been reserved by operation of Section 270.11 Florida Statutes, claim, and demand, which the Grantor has in and to the following described land lying and being in Polk County, Florida, to wit:

Assuming the West line of Section 17, Township 26 South, Range 27 East, Polk County, Florida to be a due North-South line: Commence at the Southwest corner of said Section 17 and run thence North along said West line a distance of 25 feet to the point-of-beginning: thence run North 89°55'38" East 175.28 feet; thence North 208.71 feet; thence South 89°55'38" West 239.35 feet to a point on a curve concave Southwesterly having a radius of 4422.18 feet, a chord bearing of South 15°53'59" East, and a chord length of 216.93 feet; thence along said curve through a central angle of 02°48'40" an arc distance of 216.96 feet to the end of said curve; thence North 89°55'38" East 4.64 feet to the point-of-beginning.

Being the same property described in that certain Quit Claim Deed recorded in Official Record Book 2259 at Pages 2260 and 2261, Public Records of Polk County, Florida.
