#### FIRST AMENDMENT TO INTERLOCAL AGREEMENT

Between

OSCEOLA COUNTY

and

**POLK COUNTY** 

for

**MAINTENANCE** 

for the

## WATERMARK BOULEVARD (A.K.A. SPINE ROAD) PROJECT

This is a First Amendment to an Interlocal Agreement, (the "Amendment") made and entered into by and between **OSCEOLA COUNTY**, a political subdivision of the State of Florida ("OSCEOLA") and **POLK COUNTY**, a political subdivision of the State of Florida ("POLK") (collectively referred to as the "Parties").

WHEREAS, Chapter 163, Florida Statutes, the "Florida Interlocal Cooperation Act of 1969", at Subsection 163.01, provides that public agencies of the State of Florida, which by definition includes counties, may exercise, jointly with any other public agency of the State of Florida, any power, privilege, or authority which such agencies share in common, and which each might exercise separately and may be made by contract in the form of an interlocal agreement; and

WHEREAS, OSCEOLA and POLK entered into Interlocal Agreement between Osceola County and Polk County for Maintenance for the Watermark Blvd (A.K.A. Spine Road) Project as recorded in the Official Records Book 6323, Pages 2051-2060, in the Public Records of Osceola County, Florida (the "Agreement"); and

**WHEREAS**, the Parties seek to amend the Agreement to address the maintenance of two additional sections of roadway that were not included in the Agreement.

**NOW THEREFORE**, in consideration of the promises, mutual covenants, and conditions hereinafter contained, the parties agree as follows:

**SECTION 1: Recitals.** 

The above recitals are true and correct and incorporated herein.

**SECTION 2: Amendment.** 

### A. Section 3, Subsection H is added as follows:

OSCEOLA shall maintain the section of Gingham Drive that breaks off of Lassiter Way and enters into Osceola County as more particularly described in Exhibit "A", this shall include maintenance of the section of the road that is within Polk County's jurisdiction.

## B. Section 4, Subsection E is added as follows:

POLK shall maintain the section of Lassiter Way that intersects into Watermark Boulevard (the "Spine Road") as more particularly depicted in Exhibit "B", this shall include maintenance of the section of the road that is within Osceola County's jurisdiction.

## **SECTION 3.** No Further Changes.

Except as expressly provided in this Amendment, no other terms, conditions, provisions, or obligations of the Agreement have been amended or altered by this Amendment and, thus, shall remain in full force and effect.

### **SECTION 4. Conflicts.**

If any terms of this Amendment shall conflict with any terms of the Agreement, this this Amendment shall supersede any such conflicting items in the Prior Agreement.

## **SECTION 5.** Counterparts.

This Amendment may be executed in multiple counterparts, each of which shall constitute an original, but all of which taken together shall constitute one and the same instrument, and signature pages from one counterpart may be removed and attached to another counterpart to create a single, integrated counterpart with all necessary signatures. Delivery of an executed signature page of this Amendment by facsimile or electronic transmission shall be as effective as delivery of a manually executed counterpart thereof and may be used for all purposes. Signature of the parties transmitted by facsimile or electronic transmission shall be deemed to be their original signatures for all purposes.

## **SECTION 6. Effective Date.**

Pursuant to Section 163.01(11), Florida Statutes, this Amendment shall become effective upon the filing of the fully executed Amendment in the Official Records of POLK and OSCEOLA.


