## ASSIGNMENT OF NON-EXCLUSIVE INGRESS-EGRESS EASEMENT

ASSIGNMENT made July 11, 1994, by ALBERTA S. FIORAMANTI, widow of Frank Fioramanti, deceased of P.O. Box 1805, Haines City, Florida 33845, herein referred to as ASSIGNOR, to D. WAYNE PRINGLE and BEVERLY PRINGLE, his wife; and JAMES E. RAYBORN and JANET G. RAYBORN, his wife, MICHAEL T. KELLY and MARTHA B. KELLY, his wife; FREDRICK L. MCTEER and JANE C. MCTEER, his wife; and FREDRICK L. MCTEER, a married man, their successors and assigns, herein referred to as ASSIGNEES.

WHEREAS, ASSIGNOR and her deceased husband, hereto for subdivided the
