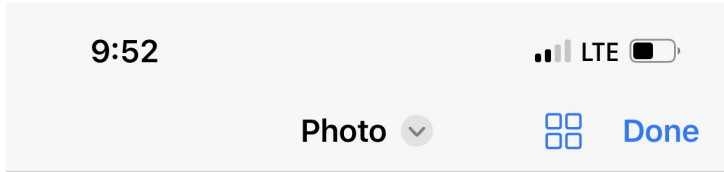

**IMPORTANT INFORMATION**

Section 316.613, Florida Statutes, requires every operator of a motor vehicle, including a child in a passenger car, van, motorcycle or pickup truck registered in this state, shall, if the child is 5 years of age or older, provide the protection of the child by properly using a crash-tested, federally approved child restraint device. For children aged through 3 years, such restraint device shall be a separate carrier, an integrated child seat, or a child booster seat manufactured after August 14, 2001. For limited exceptions, see s. 316.613, F.S.

S. 320.0605, F.S., requires the registration certificate, or true copy of the registration certificate, issued for any motor vehicle to be in the possession of the owner of the vehicle while the vehicle is being used or operated on roads of this state.

S. 320.02 and 627.733, F.S., requires personal injury protection and liability coverage to be continuously maintained throughout the registration period. Failure to maintain the mandatory coverage may result in the suspension of your driver's license.
